### ASSIGNMENT

WHEREAS, I, William Richards, a citizen of the United States, residing at Plano, Texas, United States (hereafter referred to as the "ASSIGNOR"), have invented certain new and useful improvements in LISTENER SURVEY TOOL WITH TIME STAMPING, for which I have executed a utility patent application for Letters Patent of the United States filed on February 21, 2011, Application No. 13/031,511, and

I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith.

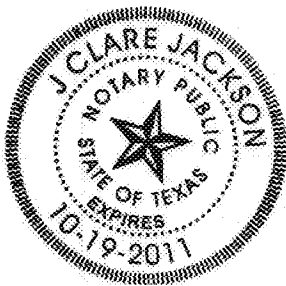
