WHEREAS, we, Larry W. Kwak and Arya Biragyn, employees of the Department of Health and Human Services, have invented "**DEFENSIN-ANTIGEN FUSION PROTEINS**," for which an international patent application was filed on September 17, 2001, and assigned International Application No. PCT/US02/29074, which subsequently entered the national phase of prosecution in the United States on March 17, 2003 and assigned U.S. Application No. 10/380,926, and claims priority to U.S. Provisional Application No. 60/233,074, filed on September 15, 2000; and

WHEREAS, we are the applicants named in the above-identified application; and

may be granted to be held by THE GOVERNMENT to the end of the term for which the same would have been held by the inventors had this assignment not been made.

We further agree to make, execute, and deliver to THE GOVERNMENT, as represented by the Secretary, Department of Health and Human Services, upon request, any and all papers, documents, affidavits, or other instruments that may be necessary in the prosecution of any application or applications for improvements or reissues of Letters Patent, and to assist THE GOVERNMENT in every way as may be requested in protecting said invention, provided that any expense of extending such assistance shall be paid by THE GOVERNMENT.

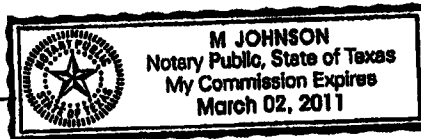



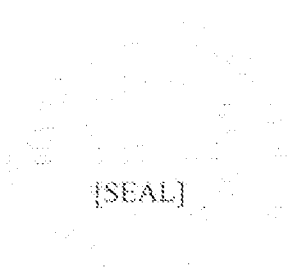
