**ASSIGNMENT**

WHEREAS, Christoph Diederichs, hereinafter called the "Assignor", has made the invention described in the United States National Application entitled "APPARATUS AND METHOD FOR PROCESSING A STENT" that has a PCT International Application Number of PCT/EP09/07008 and was filed on September 29, 2009 [nationalization in the United States Patent and Trademark Office requested on March 29, 2011, currently assigned United States Patent Application Serial No. 13/121657].

The Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representatives, that Assignor has the full right to convey the interest assigned by this Assignment; and that the Assignor will assist the Assignee in the prosecution of the patent applications identified above, in the making and prosecution of any other applications that the Assignee may elect to make covering the invention identified above, in vesting in the Assignee like exclusive title in and to all such other patent applications and patents, in the prosecution of any interference which may arise involving said invention, or any such patent application or patent, and in assisting Assignee in enforcement of any rights arising out of this Assignment; and that the Assignor will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Agreement.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
