## ASSIGNMENT OF PATENT

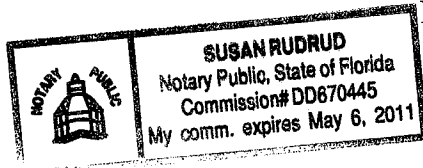
