ASSIGNMENT

WHEREAS I, Manabu OYAMA of c/o ROHM CO., LTD., 21, Saiin Mizosaki-Cho, Ukyo-Ku, Kyoto 615-8585 Japan (hereinafter referred to as "ASSIGNOR") have invented certain new and useful improvements in:

CONSTANT VOLTAGE CIRCUIT

which claims priority to Japanese Application No. JP2010-073217, filed 26 March, 2010 for which I am about to file or have filed an application for Letters Patent of the United States;
