ASSIGNMENT

MOTOR DRIVING CIRCUIT

which claims priority to Japanese Application No. JP2010-292806, filed 28 December, 2010 and JP2010-070656 filed 25 March, 2010 for which I am about to file or have filed an application for Letters Patent of the United States;

AND WHEREAS, ROHM CO., LTD.
