ASSIGNMENT

WHEREAS, We, Francesco Fazzalari, a citizen of the United States, having an address of 121 Cheltenham Lane, Oxford, MI 48371, Udo Ronnenberg, a citizen of Germany, having an address of Georg-Reimann-Str. 43, 30900 Wedemark, Germany, Ulrich Weihe, a citizen of Germany, having an address of Ritterspornweg 1, 30826 Garbsen, Germany and Jonathan LaFalce, a citizen of the United States, having an address of 17140 Jon Jon, Holly, MI 48442 (hereinafter referred to as the "ASSIGNORS"), have invented certain new and useful improvements in a **PASSENGER CAR TRANSPORT**, for which an application for Letters Patent of the United States was filed on March 4, 2011, and was assigned Serial No. 13/040,991; and

WHEREAS, each of (i) WABCO GmbH, a German company, having an address of Am Lindener Hafen 21, 30453 Hannover, Germany ("WABCO") and (ii) Meritor WABCO Vehicle Control Systems, a U.S. company, having an address of 2135 West Maple Road, Troy, MI 48084 ("Meritor WABCO") is desirous of obtaining an undivided fifty percent (50%) interest in, to and under the improvements and the application, in accordance with 35 U.S.C. §262 (WABCO and Meritor WABCO are hereinafter collectively referred to as the "ASSIGNEES," each an "ASSIGNEE").

NOW, THEREFORE, in consideration of the sum of Five Dollars (\$5.00) and other good and valuable consideration paid by ASSIGNEES to ASSIGNORS, the receipt of which is hereby acknowledged, ASSIGNORS have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto each ASSIGNEE, its respective successors, legal representatives and assigns, an undivided fifty percent (50%) interest in all right, title and interest in, to and under the improvements and the application, and all divisions, renewals, substitutes and continuations thereof, and all Letters Patent of the United States that may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent and any legal equivalent thereof, including the right to claim priority, that have been or may hereafter be filed for the improvements in any country or countries foreign to the United States, and all Letters Patent and any legal equivalent thereof that may be granted for the improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof, the same to be held and enjoyed by ASSIGNEES for their own use and benefit and for the use and benefit of their respective successors, assigns or other legal representatives as fully and entirely as if the same would have been held and enjoyed by ASSIGNORS if this Assignment had not been made, to the end of the term or terms for which any Letters Patent and any legal equivalent thereof may be granted, in accordance with 35 U.S.C. §262;

AND ASSIGNORS HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to record this Assignment, and to issue all Letters Patent for the improvements to ASSIGNEES, and their respective successors, legal representatives and assigns, as joint owners in accordance with the terms of this instrument;

AND ASSIGNORS HEREBY covenant that ASSIGNORS have the full right to convey the entire right, title and interest herein assigned, and that ASSIGNORS have not executed, and will not execute, any agreement, assignment, sale or encumbrance in conflict herewith;

AND ASSIGNORS HEREBY further covenant and agree that ASSIGNORS will communicate to ASSIGNEES, their successors, legal representatives and assigns, any facts known to ASSIGNORS respecting the improvements, and will testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEES, their successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.

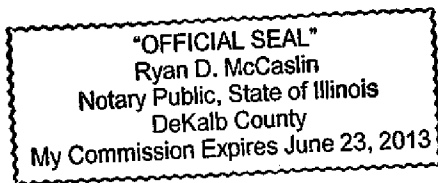
