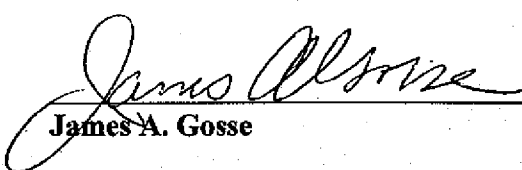
**OVERCURRENT LIMITING FOR HIGH
