

And I further covenant and agree, in consideration of the premises, that I, my executors and administrators, will at any time, upon request, communicate to Cabot Corporation, its successors and assigns, any facts relating to the invention and the improvements contained therein and the history thereof, known to me or my executors and administrators, and that I will testify as to the same in any interference or other litigation when requested so to do by Cabot Corporation, its successors and assigns.


