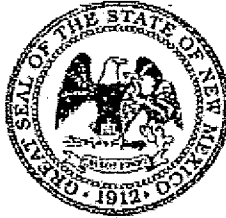

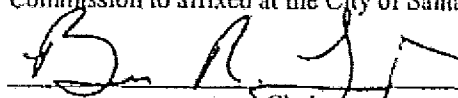

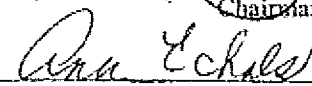

The number of shares that voted against the amendment was: 0

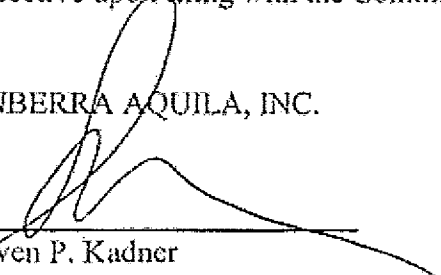

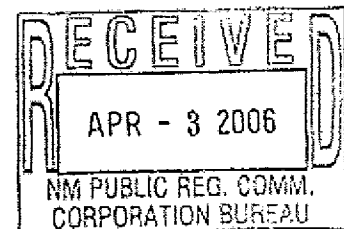
