

Said Inventors hereby warrant and represent that they/he/she have not entered and will not enter into any assignment, contract or understanding in conflict herewith.



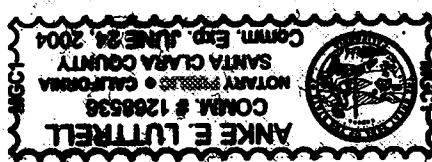


