assigns, may deem necessary or desirable to perfect Keystone Retaining Wall Systems, Inc.'s enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, continuation, divisional, reissued, re-examined or extended Letters Patent of the United States, or of any and all foreign countries on said invention, and in enforcing any rights occurring as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.

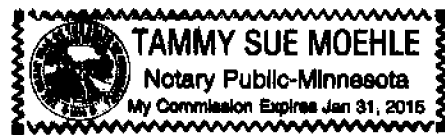


