## ASSIGNMENT

WHEREAS, I, Geoffrey Stephen Graham, of Newcastle upon Tyne, United Kingdom, have invented a certain invention as described in the following patent applications:

divisional, continuing and reissue applications, make all rightful oaths, and do everything possible to aid Wellstream International Limited, its successors and assigns to obtain and enforce proper patent protection for said invention in the United States or any foreign country.

I confirm that at the time the invention was made, I was under an obligation to assign the invention to Wellstream International Limited.

I hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment any further information which may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.
