REPRESENTS, WARRANTS, AND CONFIRMS the prior authorization of January 12, 2007, to file the above-referenced International Application in the name of Assignee.


AUTHORIZE AND REQUEST the issuing authority to issue any and all United States and foreign patents granted on such improvements to the Assignee;
