ASSIGNOR hereby covenant that no assignment, sale, agreement, charge, or other encumbrance, has been, or will be, entered into which would conflict with this assignment;



ASSIGNOR does hereby covenant and agree to aid ASSIGNEE, its successors, legal representatives and assigns in a commercially reasonable manner and at ASSIGNEE'S cost to obtain and enforce proper patent protection for the Invention in all countries including assisting with the preparation of any application relating to the Invention;

ASSIGNOR does hereby covenant and agree not to contest the validity or enforceability of any intellectual property rights assigned herein, or to assist or request any third party to contest the validity or enforceability of any intellectual property rights assigned herein;

Except for any claims arising from a breach of the EMPLOYMENT AGREEMENT by ASSIGNEE, ASSIGNOR does hereby release and forever discharge ASSIGNEE from any and all claims by ASSIGNOR relating to the Invention.
