**RECORDABLE CONFIRMATORY ASSIGNMENT**

WHEREAS, pursuant to Sections 2.1(c) and 6.2 of the Contribution Agreement, Assignor agreed to execute this Confirmatory Assignment to confirm the assignment of the Patent Rights on January 1, 2011, for the purpose of recording Assignee's rights with any appropriate patent authority in any country throughout the world, including the United States Patent and Trademark Office.

WHEREAS, to the extent that the Contribution Agreement did not assign to Assignee all of Assignor's right, title and interest in the Patent Rights, Assignor desires to assign such rights, title and interest to Assignee, and Assignee desires to accept such an assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby confirms its prior contribution, assignment and transfer to the Assignee of all of Assignor's rights, title and interest in the Patent Rights, or otherwise assigns, transfers, and contributes to the Assignee all of Assignor's rights, title and interest in the Patent Rights, including all inventions described therein.


The Assignor also hereby requests the United States Patent and Trademark Office and the relevant patent authority in any other country throughout the world to record this Assignment to the Assignee. The Assignor hereby further authorizes and requests the United States Patent and Trademark Office and any relevant patent authority in any other country throughout the world to issue any and all patent registrations resulting from the Patent Rights assigned hereunder to Assignee, or its successors and assigns, as assignee of the Assignor's entire interest herein.






