ASSIGNMENT OF PATENT

3. Without limiting the foregoing, it is understood that the rights of the Patent include all patents issued thereon and re-issues, disclaimers, and re-examinations of the same including all corresponding foreign and international patents and applications.

4. Assignors further sell, assign and transfer to Assignee all of their right, title and interest in and to all claims for damages, accounting of profit and all other legal remedies by reason of any infringement of any patent issued on the Patent, with the right to sue and collect the same.

5. Assignors agree that they will, upon reasonable request, and without further consideration, do such things and execute such further documents as are reasonably necessary to vest title thereto in Assignee, its successors, assigns and legal representatives or nominees.

6. Assignors further agree that they will, upon request, without further consideration, promptly provide to Assignee all pertinent facts and documents relating to the rights assigned hereunder as may be known and accessible to Assignors and will testify as to the same in any litigation or proceeding relating thereto and will promptly execute and deliver to Assignee, or its


legal representatives, any and all papers, instruments and affidavits which may be necessary or desirable to enforce such rights or to carry out the purposes hereof.

7. Assignors agree to reasonably assist Assignee in the prosecution before the United States Patent and Trademark Office, foreign patent offices and the Federal Courts of any matters directly relating to the Patent (at the sole cost of Assignee) that Assignee elects to make covering the Patent.


8. This assignment and all the terms hereof shall inure to the benefit of and be binding upon the parties hereto and their respective successors, assigns and legal representatives.


