I hereby acknowledge that this assignment, being of my entire right, title and interest in and to said inventions, carries with it the right in Nanoptek to apply for and obtain from competent authorities in all countries of the world any and all Letters Patent by attorneys and agents of Nanoptek's selection and the right to procure the grant of all Letters Patent to Nanoptek for its own name as Nanoptek of my entire right, title and interest therein.
