**TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENTS**


WHEREAS ASTON MARTIN LAGONDA LIMITED, a company organized under the laws of England & Wales with an address at Banbury Road, Gaydon, Warwick, CV35 0DB (the "Grantor"), entered into a certain security agreement dated July 12, 2007 (the "Security Agreement") with WestLB AG, London Branch, a European commercial bank (the "Collateral Agent"), notice of which was recorded on October 10, 2007 in the United States Patent and Trademark Office at Reel 019943, Frame 0001.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Security Agreement (Patents and Trademarks), a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in and to certain of Grantor's intellectual property, including without limitation the patents listed in Schedule A (collectively, the "Patents") as well as all proceeds and claims based on past, present, or future infringement.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Patents as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges all interest in the Patents, including the Security Interest and any other liens, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
