HIGH SPATIAL RESOLUTION PARTICLE DETECTORS

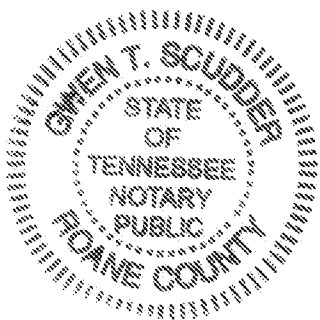

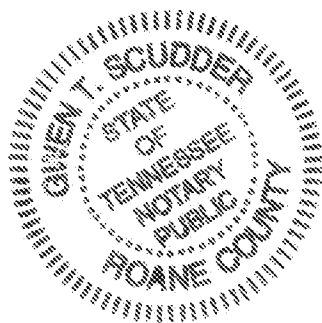
