### AGREEMENT



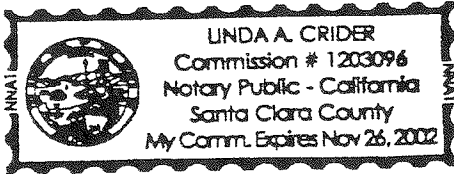
