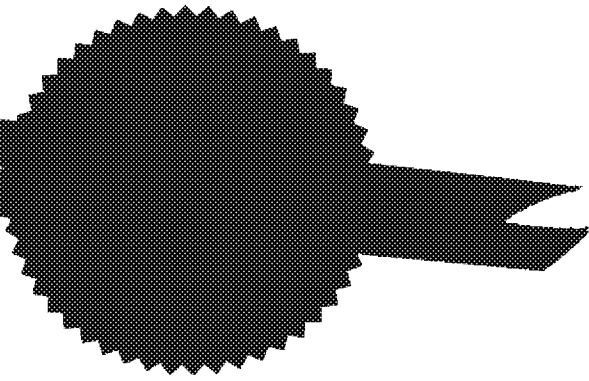

included therein to BP CORPORATION NORTH AMERICA INC. as assignees of the entire interest therein.

And WE hereby covenant that WE have full right to convey the entire interest herein assigned, and that WE have not executed, and will not execute any agreement or other instrument in conflict herewith.

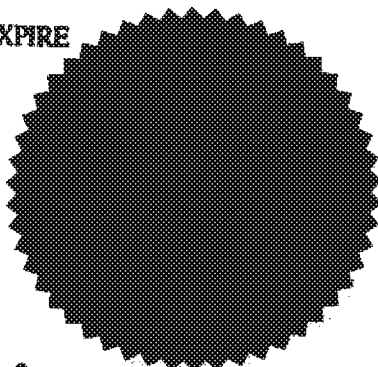
