### ASSIGNMENT OF RIGHTS

**WHEREAS**, Bernd Koehler, a citizen of Germany, residing at 11 allée des Pastels, 69230 St. Genis Laval, France, and Fabrice Renault, a citizen of France, residing at 30 rue Maurice Ribaud, 69680 Chassieu, France; (the ASSIGNORS), has invented certain new and useful improvements disclosed in the United States Patent Application entitled "Electric Steam Iron," filed herewith (the INVENTION); and
