**ASSIGNMENT OF INVENTION**

WHEREAS, I, **Markus BERBERICH**, Ringstr. 29, 69115 Heidelberg, Germany; and **Christian WILKE**, Am Wolfsberg 15, 64668 Rimbach, Germany, have invented certain new and useful improvements in a **AUTOMATIC CALIBRATION OF A STAINING DEVICE**, for which an application for Letters Patent in the United States was executed on the date which appears next to my signature;


