**RELEASE OF PATENT SECURITY INTEREST**

THIS RELEASE OF PATENT SECURITY INTEREST is made effective as of June 17, 2011 by and from JPMORGAN CHASE BANK N.A., for itself and as Administrative Agent for the Secured Parties (the "Administrative Agent") to ENDO PHARMACEUTICALS INC., a Delaware corporation (the "Grantor"), as follows:

WHEREAS, on November 30, 2010 the Grantor and the Administrative Agent entered into a Pledge and Security Agreement (the "Security Agreement") and a Confirmatory Grant of Security Interest in United States Patents (the "Confirmatory Grant");

WHEREAS, pursuant to the Security Agreement and the Confirmatory Grant, the Grantor pledged and granted to the Administrative Agent on behalf of and for the benefit of the Secured Parties, among other collateral, a security interest in (1) all of the Grantor's right, title and interest in and to the patents and patent applications, including the United States Patents listed on the attached Schedule A (the "Patents"), then owned or from time to time after the date thereof owned or acquired by the Grantor; (2) all inventions and improvements described and claimed therein; (3) all reissues, divisions, continuations, renewals, extensions, and continuations-in-part thereof; (4) all income, royalties, damages, claims, and payments now or hereafter due or payable under and with respect thereto, including, without limitation, damages and payments for past and future infringements thereof; and (5) all rights to sue for past, present, and future infringements thereof;

WHEREAS, the Confirmatory Grant was recorded in the United States Patent & Trademark Office on December 1, 2010 at reel/frame 25416/381; and

WHEREAS, the Administrative Agent wishes to release its security interest in the foregoing.


