**ASSIGNMENT**

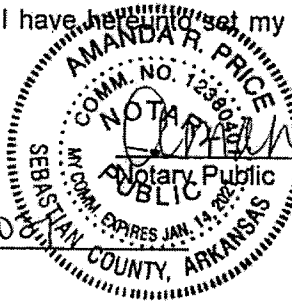
