ASSIGNMENT

AND I DO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue that said Letters Patent, when granted, to the said **R.J. Liebe Athletic Lettering Company**, a corporation, its successors and assigns, as assignees of the entire right, title and interest in and to said improvements, for the sole use and behoof of said **R.J. Liebe Athletic Lettering Company**, a corporation, and for its successors and assigns, to the full ends of the terms for which Letters Patent may be granted.

AND I further grant to **R.J. Liebe Athletic Lettering Company**, a corporation, its successors and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.
