ASSIGNMENT

WHEREAS, we, Shigeyoshi Nishihara, Takashi Fukuda, Hirohito Takeichi and Hirofumi Fujisaki, have invented a DIPPING APPARATUS for which we are about to make application for Letters Patent of the United States; and

AND, we hereby covenant and agree for myself, my heirs, and my legal representatives, to assist DAIFUKU in the prosecution of said application and in any interference which may arise involving said invention, and, upon the request of DAIFUKU, to execute without further consideration all other documents that might be deemed necessary by either of them fully to secure their respective interests as aforesaid in and to said invention or any part thereof, and in and to said patents or any of them.
