RELEASE OF PATENT SECURITY AGREEMENT

WHEREAS, pursuant to that certain Patent Security Agreement, dated as of June 29, 2007 (the "Patent Security Agreement"), recorded at the United States Patent and Trademark Office at Reel 19511, Frame 611 on July 5, 2007, JONATHAN MANUFACTURED CORPORATION, a Delaware corporation ("Releasee"), mortgaged, pledged and hypothecated to GENERAL ELECTRIC CAPITAL CORPORATION ("Releasor"), as administrative agent for the benefit of the Secured Parties, and granted to Releasor for the benefit of the Secured Parties, a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of Releasee (collectively, the "Patent Collateral"): (i) all of its Patents and all IP Licenses providing for the grant by or to such Releasee of any right under any Patent, including, without limitation, those referred to on Schedule A hereto; (ii) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and (iii) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof; and

WHEREAS, Releasee has requested and Releasor has agreed to release, relinquish and discharge its Lien on and security interest in, to and under the Patent Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:


1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Patent Security Agreement.
