
In consideration of the promises and covenants set forth in this Patent Assignment and in the Intellectual Property Assignment, the Parties agree as follows:

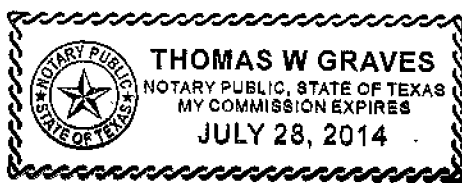

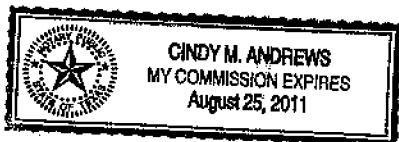
