I (We), the undersigned inventor(s), in consideration of the rights of the Government of the United States acquired by virtue of the circumstances under which the above-entitled invention was made, hereby:

1. Assign to the Government of the United States, as represented by the Secretary of the Army, the entire right, title and interest throughout the United States, its Territories, Possessions and Puerto Rico, in and to the above-identified invention(s), provisional application(s), application(s) for patent, and Patent Cooperation Treaty application(s), and all Letters Patent issuing thereon, and any continuation, continuation-in-part or division of said application(s) and any reissue or extension of said Letters Patent.

2.
