ASSIGNMENT

We, Jong-sang Park, Young Hun Choi, of Seoul, Korea, and Feng Liu of Salt Lake City, Utah, respectively, have invented a method and apparatus entitled LACTOSE-POLYETHYLENE GLYCOL-GRAFTED POLY-L-LYSINE AS A HEPATOMA CELL-TARGETED GENE CARRIER, hereinafter called the "invention."


