**ARTICLES OF ENTITY CONVERSION  
OF  
VONTOO, LLC  
INTO  
VONTOO, INC.**

The undersigned, Vontoo, LLC (the "Converting Entity"), an Indiana limited liability company, in compliance with the requirements of Section 23-1-38.5 of the Indiana Business Corporation Law, as amended (the "IBCL"), and desiring to effect a conversion of the Converting Entity into Vontoo, Inc., an Indiana corporation (the "Surviving Corporation"), hereby sets forth the following facts:

**ARTICLE I  
NON-SURVIVING ENTITY**

A. The name of the Converting Entity immediately before filing these Articles of Entity Conversion is Vontoo, LLC.

B. The Converting Entity is an Indiana limited liability company existing pursuant to the provisions of the Indiana Business Flexibility Act, as amended (the "IBFA") and was organized on March 15, 2006.

**ARTICLE II  
SURVIVING CORPORATION**

A. The name of the Surviving Corporation is Vontoo, Inc.

B. The Surviving Corporation is an Indiana corporation existing pursuant to the provisions of the IBCL.

C. The street address of the Surviving Corporation's Principal Office is 8606 Allisonville Road, Suite 260, Indianapolis, Indiana 46250.

**ARTICLE III  
REGISTERED OFFICE AND AGENT**

The street address of the registered office of the Surviving Corporation is its Principal Office. The name of the registered agent of the Surviving Corporation at the registered office is Dustin Sapp.

**ARTICLE IV  
PLAN OF ENTITY CONVERSION**

The Plan of Entity Conversion, containing such information as is required by Section 23-1-38.5-11 of the IBCL, was duly approved in accordance with the IBFA.

**ARTICLE V**  
**ARTICLES OF INCORPORATION**

The Articles of Incorporation of the Surviving Corporation are attached hereto and made a part hereof as Exhibit A.

**ARTICLE VI**  
**EFFECTIVE TIME**

The effective time and date of the conversion hereby effectuated shall be at 11:59 p.m. on the 29<sup>th</sup> day of February, 2008.
