RELEASE OF SECURITY INTEREST IN A CERTAIN PATENT

This Release of Security Interest in a Certain Patent (this "Release") is made and effective as of July 25, 2011 by A. Karl Kipke, (as "Collateral Agent" under the Security Agreement defined below).

RECITALS

WHEREAS, pursuant to terms of that certain Security Agreement (the "Security Agreement") dated March 3, 2011, by and between Amedica Corporation, a Delaware corporation (the "Debtor"), and Collateral Agent, for the noteholders participating in Amedica's Senior Secured Subordinated Convertible Promissory Notes (collectively the "Secured Parties"), Debtor granted to the Secured Parties, a security interest in U.S. Patent Number 7,235,103 titled "*Artificial Intervertebral Disc*," (the "Released Patent") to secure the repayment of the Senior Secured Subordinated Convertible Promissory Notes, which Security Agreement was made of record in the U.S. Patent Office on March 4, 2011 at Reel 025900, Frame 0168.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:


Release of Security Interest
