WHEREAS, Assignee is desirous of acquiring the Patents as well as the related applications, registrations and common law rights thereto; and

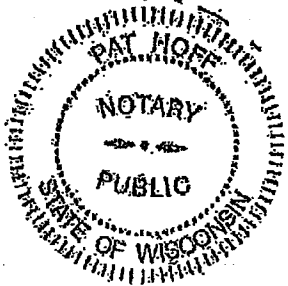

1. Assignment of Patents. For value received and on the terms and subject to the conditions of the Asset Purchase Agreement, Assignor hereby irrevocably sells, transfers, conveys, assigns and delivers to Assignee, and Assignee hereby purchases, acquires, accepts and takes assignment and delivery from Assignor of, all of Assignor's right, title and interest in and to the Patents, including the goodwill associated therewith, and any related registrations and common law rights thereto.
2. Asset Purchase Agreement. This Assignment is being executed and delivered pursuant and subject to the Asset Purchase Agreement. Nothing in this Assignment shall, or shall be deemed to, defeat, limit, alter or impair, enhance or enlarge any right, obligation, claim or remedy created by the Asset Purchase Agreement. In the event of any conflict between this Assignment and the Asset Purchase Agreement, the Asset Purchase Agreement shall control.
3. Successor and Assigns. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns.
4. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Wisconsin without giving effect to any choice or conflict of law provision or rule (whether of the State of Wisconsin or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Wisconsin.
5. Counterparts. This Assignment may be executed in one or more counterparts (including by means of facsimile or electronic means including pdf form), each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

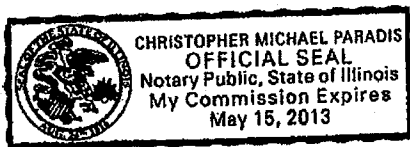
