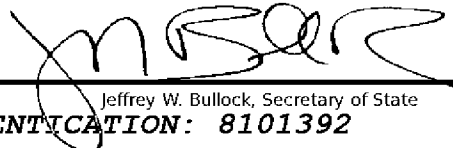

Pursuant to the provisions of Section 253 of the General Corporation Law of the State of Delaware (the "DGCL"), ACTV, Inc., a Delaware corporation ("Parent"), hereby certify that:

**FIRST:** Parent owns 100% of the shares of capital stock of Intellocity USA, Inc., a Delaware corporation ("Intellocity USA"), which was incorporated on September 17, 1999, pursuant to the provisions of the DGCL.

**SECOND:** On June 28, 2010, the Board of Directors of Parent determined to merge into itself Intellocity USA, pursuant to the following resolutions:

FURTHER RESOLVED, that the officers of this corporation be and they hereby are authorized and directed to do all acts and things whatsoever, which may be in any way necessary or proper to effect said merger of Intellocity USA with and into this corporation."
