(the intellectual property assets as a whole are hereinafter referred to as the IP ASSET)




2. ASSIGNOR further covenants that no assignments, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.
3. ASSIGNOR further authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Letters Patent referred to above to ASSIGNEE, as the ASSIGNEE of the entire right, title and interest in and to the same, for ASSIGNEE'S sole use and behoof; and for the use and behoof of ASSIGNEE'S legal representatives and successors, to the full end of the term for which such Letters Patents may be granted, as fully and entirely as the same would have been held by ASSIGNOR had this assignment and sale not been made.
4. ASSIGNOR assigns no rights to Assignee other than those transferred hereunder, and Assignor retains any and all right, title and interest in any patents, copyrights or intellectual property of any kind not expressly conveyed herein.
