"The name of this corporation is Renesas Electronics America Inc."



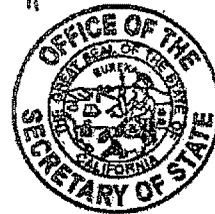
