
## ASSIGNMENT

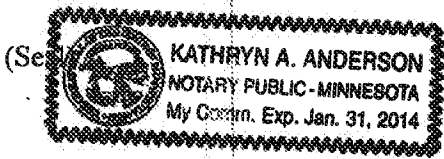

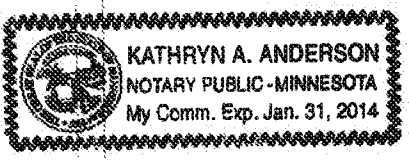
