I refer to telephone conversation of today with you regarding ownership and rights to the ICON technology, and I hereby confirm that Heggset Engineering is the owner and has the rights to this technology. Cinnova Inc by the undersigned is listed as co-inventor for the patent application, but the rights have transferred to Heggset Engineering.

Further, I confirm that there are no conflicts with Hycast AS regarding rights, ownership or patents as regards the ICON technology. This is also confirmed per telephone by the manager of Hycast AS, Roar Ørsund, on 28 March 2006. The development of ICON is solely a cooperation between Heggset Engineering and Cinnova Inc.

This implies that Heggset Engineering is the formal contracting partner. Cinnova Inc is responsible for sales, marketing, contract and project clarifications for Heggset Engineering.

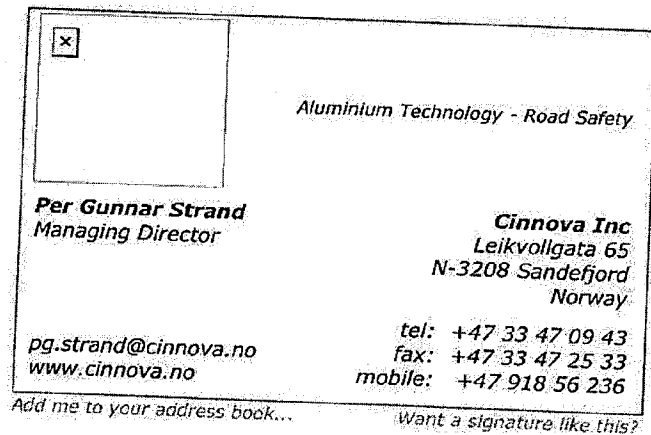

This is in response to the renewed petition under 37 CFR 1.47(a) filed on 10 January 2011.

DISCUSSION

The Decision mailed on 11 March 2011 is VACATED.

In a Decision mailed on 09 November 2010, the petition under 37 CFR 1.47(a) filed on 04 November 2009 was dismissed, without prejudice, because requirements (2) and (4) had not been satisfied.

In response, with respect to **requirement (2)**, petitioner has provided an "Updated Statement of Facts" signed by Lars Erik Hatlen, who indicates that he sent a copy of the application to Mr. Strand on 07 December 2010, and that on 22 December 2010, he received a reply in which Mr. Strand refused to execute the application. Also provided are copies of the letters, and an English translation of the 07 December 2010 letter. Upon review of the evidence now of record, including Mr. Strand's letter dated 20 December 2010, it would be appropriate to conclude that he has refused to execute the application within the meaning of 37 CFR 1.47(a).

Regarding **requirement (4)**, petitioner has provided what appears to be a copy of the "Added Page" of the declaration filed on 04 November 2009, which was later modified and dated by Mr. Vaagland. This constitutes an alteration of the declaration after it was signed. Alternatively, this sheet taken alone is not a complete declaration. However, petitioner also states that, on the declaration filed on 04 November 2009, "there was a typographical error in the name of the inventor, Jo Henrik VAAGLAND." In view of petitioner's characterization of the discrepancy as a typographical error (and the spelling offered as a "corrected version"), and under the policy described at MPEP 605.04(b), it would be appropriate to accept the declaration filed on 04 November 2009 in satisfaction of requirement (4).

DECISION

The petition under 37 CFR 1.47(a) is GRANTED.

As provided in 37 CFR 1.47(a), a notice of the filing of this application will be forwarded to the non-signing inventor at his last known address of record.

A notice of the filing of the application under 37 CFR 1.47(a) will be published in the Official Gazette.

This application is being returned to the Office of Patent Application Processing. Its date under 35 U.S.C. 371(c)(1), (2) and (4) is **04 November 2009**.
