
## PATENT APPLICATION ASSIGNMENT

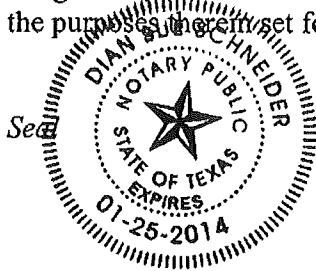
