RELEASE OF PATENT SECURITY INTEREST, dated as of May 31, 2011 (this "Release"), by WELLS FARGO BANK, NATIONAL ASSOCIATION (as successor in interest to Wachovia Bank, National Association), as Collateral Agent (as defined below). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Amended and Restated Credit Agreement dated as of July 3, 2007, as further amended and restated as of December 18, 2009 (as further amended, restated or amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Springs Industries, Inc. ("Holdings"), Springs Window Fashions, LLC (the "Borrower"), the lenders from time to time party thereto (the "Lenders") and Wells Fargo Bank, National Association (as successor in interest to Wachovia Bank, National Association) ("Wells Fargo"), as administrative agent for the Term Lenders (as defined therein) and collateral agent and JPMorgan Chase Bank, N.A., as administrative agent for the Revolving Lenders (as defined therein), (ii) the Security Agreement, dated as of July 3, 2007 (as amended, restated or amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Borrower, Holdings, the subsidiaries of the Borrower from time to time party thereto and Wells Fargo, as collateral agent (the "Collateral Agent") and (iii) the Patent Security Agreement dated as of July 3, 2007 (the "Patent Security Agreement"), made by Holdings, the Borrower and Springs Window Fashions Manufacturing Co. USA, Inc. (collectively, the "Grantors") in favor of the Collateral Agent (such documents set forth in clauses (i) through (iii), the "Collateral Agreements").

B. Pursuant to the Collateral Agreements, among other things, the Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in, among other things, the patents of the Grantors set forth on Schedule I hereto (the "Patents").

C. The Patent Security Agreement was recorded with the United States Patent & Trademark Office on August 28, 2007 at Reel/Frame 19744/0986 and August 28, 2007 at Reel/Frame 19744/0514.

D. In connection with the repayment of all Indebtedness and the termination of all Commitments under the Credit Agreement, and the release of security interests under the Loan Documents, the Grantors has informed the Collateral Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent, the Secured Parties and each other grantee or beneficiary in and to the Patents granted under the Collateral Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all of the Collateral Agent's right, title

and interest (including, without limitation, security interests) in and to the Patents shall automatically terminate as provided in the Collateral Agreements, and the Collateral Agent hereby terminates, releases and discharges its security interests in the Patents.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
