**DECLARATION OF MR. SHMUEL HERSHKOVITZ**

I, MR. SHMUEL HERSHKOVITZ, having been duly sworn on oath, state as follows:

1. I reside at 53 Fortune Bay Inlet, Freeport, Bahamas. This address is shown on my Declarations filed in at least U.S. Applications 11/599,666, 11/381,675, and 12/299,756.
2. An inadvertent typographical/drafting error was made in the Assignment for the 11/559,666 application in the first line of the second paragraph in that the words "a corporation" should never have been inserted after "Shmuel HersHKovitz,". The assignment should have assigned U.S. Patent Applications 11/559,666 (U.S. Patent 7,671,729) and all continuation applications to me as a person, and not as a corporation.
3. The address listed on the Assignment is my personal address, and is not, nor has it ever been, the address of "Shmuel HersHKovitz, a corporation of Freeport, Bahamas."
4. There is not now, nor has there even been, to the best of my knowledge, a "Shmuel HersHKovitz, a corporation of Freeport, Bahamas."


