SEMEN CONTAINER WITH SPECIALIZED TIP

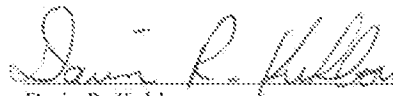

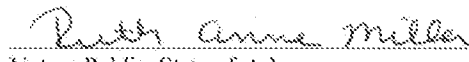

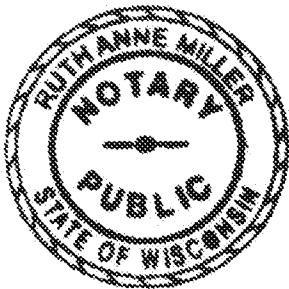
