## RELEASE OF PATENT SECURITY INTEREST

(Pylon Manufacturing Corp.)

(ii) All income, royalties, damages, payments and proceeds of the foregoing, including without limitation any claim by the Grantor against third parties for damages by reason of past, present or future infringement of any patent, patent registration and patent application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such patent, patent registration and patent application, in each case together with the right to sue for and collect said damages.
