

KNOW ALL MEN BY THESE PRESENTS:


1. The name of the corporation is Peripheral Solutions, Inc.

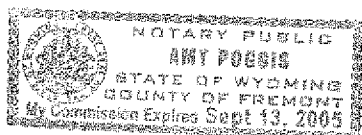
