CORRECTIVE ASSIGNMENT

WHEREAS, we, Adam B. Roach of Dallas, Texas; Robert J. Sparks of Plano, Texas; Ben A. Campbell of Irving, Texas; Ajay Deo of Carrollton, Texas; and Sam E. McMurry of Richardson, Texas (hereinafter "Assignors"), have invented certain new and useful improvements in METHODS, SYSTEMS AND COMPUTER READABLE MEDIA FOR PROVIDING SESSION INITIATION PROTOCOL (SIP) EVENT WATCHER ENTITY INFORMATION IN A COMMUNICATIONS NETWORK (hereinafter, Invention) for which application for a U.S. Patent was made on January 6, 2011 as Serial No. 12/985,967 (hereinafter, Application).

AND, WHEREAS, Tekelec, a corporation duly organized and existing under the laws of the state of California, having its principal office and place of business at 5200 Paramount Parkway, Morrisville, North Carolina 27560 (hereinafter "Assignee"), is desirous of acquiring an interest therein.

WHEREAS, Assignors acknowledge having previously executed an assignment of the Invention and Application to Tekelec on (February 3, 2011, February 7, 2011, February 11, 2011, February 7, 2011, & February 7, 2011, respectively) (hereinafter, "Previous Assignment") in which Tekelec was erroneously identified as being a corporation duly organized and existing under the laws of the state of Delaware, Assignors execute this Corrective Assignment to clarify that the Previous Assignment was intended to assign all rights in the Invention and Application to Tekelec, a corporation duly organized and existing under the laws of the state of California.

NOW, THEREFORE, To Whom It May Concern, be it known that for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors have sold and by these presents do hereby sell, assign, transfer and convey unto the Assignee, its successors and assigns, their entire right, title and interest in and to the Invention and Application, and in and to any and all

foreign patent applications filed on the Invention, and in and to any and all continuations, continuations-in-part, or divisions thereof, and in and to any and all Letters Patent of the United States of America and all foreign countries or reissues thereof which may be granted therefor or thereon, for the full end of the term for which said Letters Patent may be granted, together with their right to claim the priority of the Application in all countries in accordance with the Paris Convention, the Patent Cooperation Treaty, or other agreement or national law under which priority can be claimed, the same to be held and enjoyed by said Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignors if this assignment and sale had not been made.


Assignors hereby request that said Letters Patent be issued in accordance with this Corrective Assignment.

Assignors further covenant and agree that, at the time of the execution and delivery of these presents, Assignors possess the unencumbered right and authority to make this Corrective Assignment.

Assignors further covenant and agree, and likewise bind their heirs, legal representatives and assigns, to promptly communicate to said Assignee or its representatives any facts known to them relating to the Invention, to testify in any interference or legal proceedings involving the Application or Invention, to execute any additional papers which may be requested to confirm the right of the Assignee, its representatives, successors and assigns to secure patent or similar protection for the Invention in all countries and to vest in the Assignee complete title to the Invention and Letters Patent, without further compensation, but at the expense of said Assignee, its successors, assigns and other legal representatives.




