NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto, intending to be legally bound hereby, agree as follows:

1. Assigned Patents. "Assigned Patents" means the issued patents and pending patent applications listed on Schedule 1 attached hereto.

2. Confirmatory Assignment. In accordance with and subject to the terms of this Confirmatory Assignment, Inventor hereby assigns, transfers and conveys to Armstrong all of Inventor's right, title and interest in, under and to the Assigned Patents, including provisional applications, substitutions, continuations, continuations-in-part, divisions and renewals thereof and any patents granted thereon, patents-of-addition, reissues, reexaminations, confirmations, re-registrations, and extensions or restorations by existing or future extension or restoration mechanisms thereof (including supplementary protection certificates or the equivalent thereof), and foreign counterparts of any of the foregoing, together with any claims and the right to make claims against third parties for infringement or other violation of any of the Assigned Patents, whether for any past, present or future infringement or other violation, including the right to settle and retain proceeds from any such claims, and any right or any future right to receive royalties based on any such claim.

3. Parties in Interest. This Confirmatory Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns.

4. Counterparts. This Confirmatory Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, and all of which together shall constitute one and the same instrument.

5. Governing Law. This Confirmatory Assignment and the rights and obligations of the parties hereunder shall be governed by, and construed in accordance with, the laws of the State of Pennsylvania as applied to contracts made and performed entirely in the State of Pennsylvania without giving effect to the choice of law principles of the State of Pennsylvania that would require or permit the application of the laws of another jurisdiction.


