TERMINATION OF SECURITY INTEREST IN UNITED STATES PATENTS

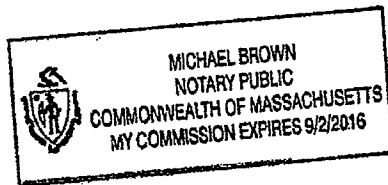
