PARTIAL RELEASE OF GRANT OF A SECURITY INTEREST -- PATENTS

This PARTIAL RELEASE OF GRANT OF A SECURITY INTEREST -- PATENTS (the "Partial Release") is made and effective as of the date indicated below and is granted by FSJC VII, LLC, as the Administrative Agent ("Releasor"), in favor of Walbro Engine Management, L.L.C., a Delaware limited liability company ("Releasee").

WHEREAS, Releasee has requested that Releasor release and discharge fully its security interest in and to the patent listed on **Schedule I** hereto, including all registrations and applications therefor and all rights associated therewith (the "Released Patent"); and

WHEREAS, Releasor is willing to release and discharge fully its continuing security interest in and to the Released Patent.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings give to them in the Patent Security Agreement.
2. Partial Release of Patent Security Agreement. Releasor hereby, without any representation and warranty and without any recourse to Releasor, releases, relinquishes and discharges its continuing security interest in the Released Patent. For the avoidance of doubt, Releasee acknowledges and agrees that this Partial Release does not release, relinquish or discharge Releasor's security interest in any Collateral (as defined in the Patent Security Agreement) other than the Released Patent.
